Continue to the end of Glenwood and turn left onto Golf, it becomes South First St. after it curves to the left. The field will be on the left after the veterinary clinic.

Check-in - the dog's permanent registration card shall be shown. If a dog measures for a higher jump height, the dog must move to that height. If this does happen, the handler may elect to change height categories to enable the dog to remain at the lower height. If the handler elects to do so, the host club may charge a nominal fee of \$5 for the paperwork changes.

A general exhibitors' briefing will be given following measuring and check-in, before the trial starts. Exhibitors not attending the general briefing will still be subject to the terms and conditions set forth in such a briefing. Neither the judge(s) nor the host club is required to provide details of the general briefing once it has been given.

Final Move-Up Date is September 11th 9PM. Also there will be move-ups from Fri for Sat and Sat for Sun. Please remember to check your scores on your last day of entry. Once Cheryl leaves we cannot change them.
