CANOPY SETUP/RVERS/CAMPERS: The field will not be accessible until **3:00PM on Friday**. Please do not enter the field or set up canopies before **3:00PM** - we may need that space and will have to move you. Those with large RVs are asked to park along the fence between the backfields first. *Hookup to the electricity and water sources by recreational vehicles is not permitted. There is a full RV station at the Chevron Station on Glenwood and Lander. Generators are not permitted in the backfield.*

Spaces are first come first served.

General parking for cars (those people not camping) are not permitted in the backfield. This area is reserved for tent and car campers. Thanks for your co-operation.

Check-in (only check in on your first day)

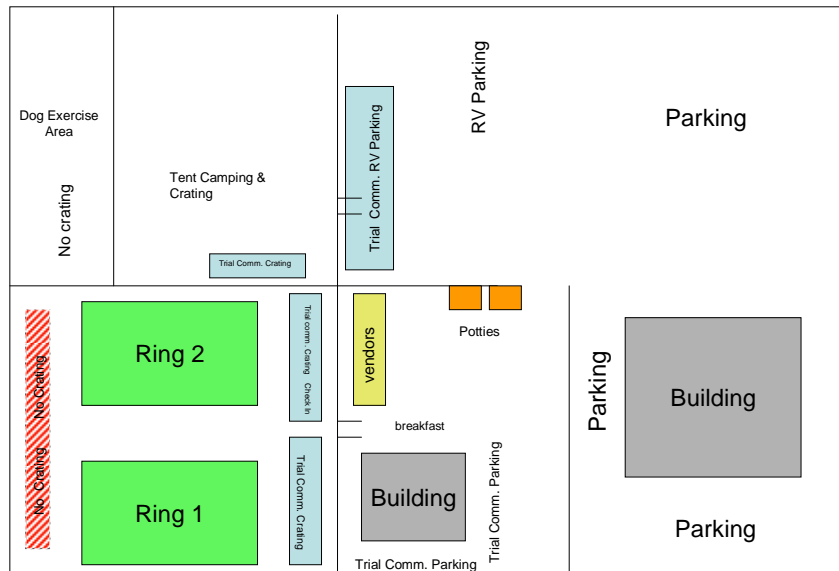
- (1) If you **don't** have a permanent height card or a temporary height card with three signatures on it
